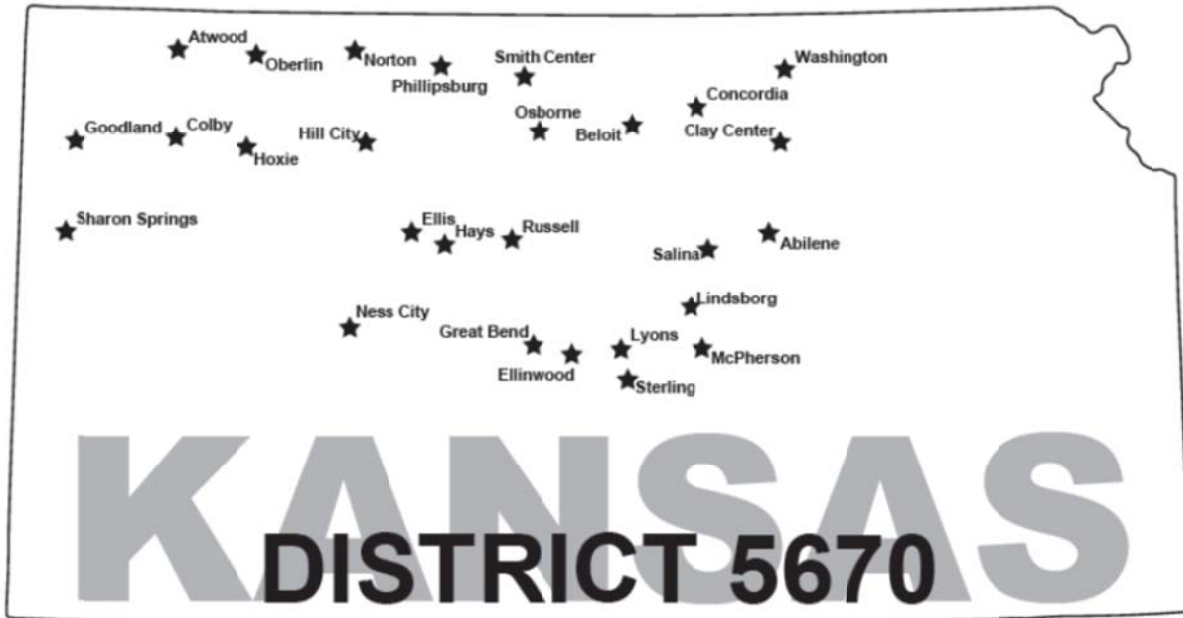

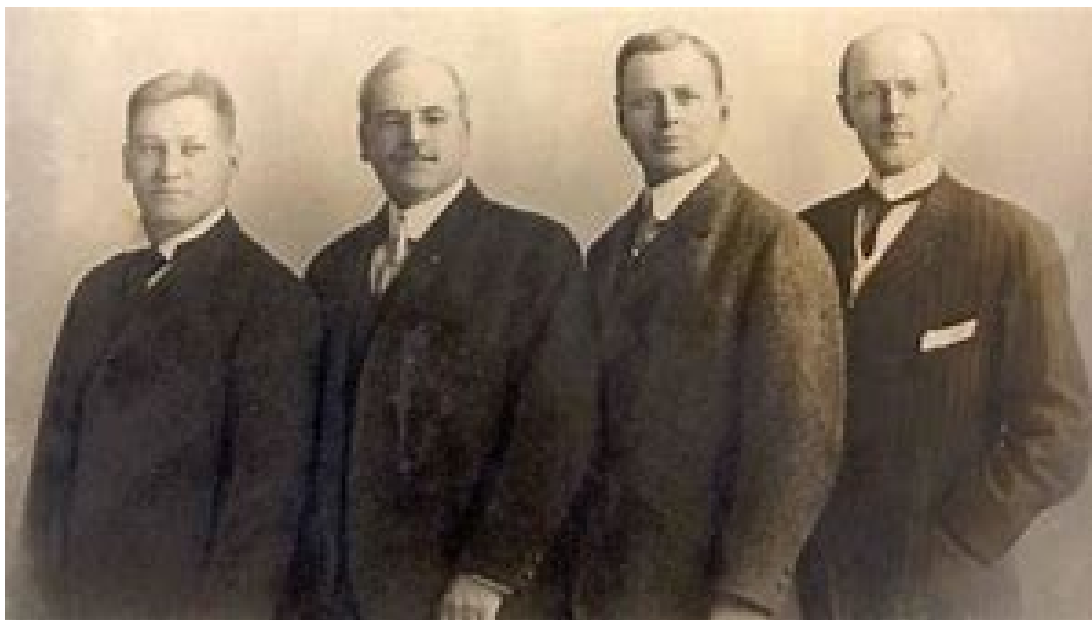
Early History of Rotary International

The world's first service club, the Rotary Club of Chicago, was formed on February 23, 1905, by Paul P. Harris, an attorney who wished to capture in a professional club the same friendly spirit he felt in the small towns of his youth. The Rotary name derived from the early practice of rotating meetings among members' offices.

Rotary's popularity spread and within a decade, clubs were chartered from San Francisco to New York to Winnipeg, Canada. By 1921, Rotary clubs had been formed on six continents. The organization adopted the Rotary International name a year later.

As Rotary grew, its mission expanded beyond serving club members' professional and social interests. Rotarians began pooling their resources and contributing their talents to help serve communities in need. The organization's dedication to this ideal is best expressed in its motto: **SERVICE ABOVE SELF.**

Rotary now has 1.22 Million members and more than 34,000 clubs in over 200 countries.

PRESIDENTIAL MESSAGE:

One year ago, your Rotary International Board of Directors adopted a new vision statement, reflecting our aspirations for our organization and its future. It reads, “Together, we see a world where people unite and take action to create lasting change – across the globe, in our communities, and in ourselves.”

That simple sentence distills so much of what is essential about Rotary. We **unite**, because we know that we are far stronger together than we could ever be alone. Let’s give all Rotarians the flexibility to serve in the ways that work best for them, so that every Rotarian finds enduring value in Rotary membership.

Truly sustainable service, the kind of service we strive for in Rotary, means looking at everything we do as part of a larger global ecology. This year, I ask all of you to ***Be the Inspiration*** for sustainable service by addressing the impact of environmental issues on our work. The environment plays a key role in all six of our areas of focus, and that role is only becoming greater as the impact of climate change unfolds. It’s time to move past seeing the environment as somehow separate from those six areas. Clean air, water, and land are essential for healthy communities – and essential for the better, healthier, future we strive for.

Be the Inspiration – and together we can, and we will, inspire the world.

Andrea graduated from Kansas State University with Bachelor of Science degrees in Accounting and Agricultural Economics. After graduation, she worked in the tax division of Arthur Andersen & Co. in Kansas City for three years, during which time she became a Certified Public Accountant.

Andrea then moved back to Manhattan, KS and began working for DPRA Incorporated, a consulting firm, while also working tax seasons for Varney & Associates, CPAs. During this time, she earned a Master of Business Administration from KSU and taught Business Strategy as an adjunct professor at KSU.

In 2002, Andrea returned to her hometown of Russell, KS to take her current position of Secretary/Treasurer at John O. Farmer, Inc., an oil exploration and production company. She is on the board of the Kansas Independent Oil & Gas Association, serving as their Federal and State Tax Committee chairman, and was the 2015 recipient of the KIOGA President's Leadership Award.

Kurt Harper was born in Wichita, Kansas in 1954. He attended the University of Kansas, receiving a bachelor's degree in Russian Language and Literature and an associate degree in Slavic and Soviet Area Studies in December, 1975. During his studies, he participated in a 6-week language institute in what was then Leningrad during the summer of 1974. Upon graduation, he was admitted into Phi Beta Kappa.

Kurt went on to obtain a law degree, also from the University of Kansas, in 1979.

Kurt is married to Kelly Harper, also a native of Wichita, and they have 2 adult children.

Both Kurt and Kelly are natives of Wichita, Kansas. Kelly is fluent in French, and they love domestic and international travel, having just completed two trips to Russia—one for the Russia-US Intercountry Committee, the other to attend World Cup games.

Kurt has practiced law in Wichita, Kansas, from 1979 to the present, where his practice focuses principally on commercial litigation. Dana Brewer, a member of the Concordia Rotary Club for 30 years, has a deep personal connection with the disease of poliomyelitis or “polio”. Both of his parents were polio survivors. Dana shares their combined life stories, as affected by polio, because he is passionate about the need to end the horrid disease’s chances to make people’s lives more difficult. He is also keenly aware that an ever increasing number of Rotarians have no firsthand experience nor even know people who have experienced its worst paralyzing symptoms.

Lest we forget the underlying reasons for our quest to eliminate polio’s threat to humankind, Dana will be sharing the trials, tribulations and triumphs of his family’s fight against becoming victims of polio’s aftereffects.

Dana is a Past President of the Concordia Rotary Club and a two time Membership Chairperson for District 5670. He served as Assistant or “Area” District Governor for the Beloit, Clay Center, Washington and Concordia Clubs in North Central Kansas for 2017-2018.

Dana graduated from Kansas State University in 1974. He earned a Juris Doctor from the Washburn University School of Law in 1977. Dana has practiced law in Concordia Kansas for over forty years and is now the owner of the Brewer Law Firm, LLC in Concordia.

Among other positions he has held, he is now General Counsel of Court Appointed Special Advocates (CASA) of North Central Kansas and CloudCorp (area economic development organization) and is a member of the Twelfth Judicial District Nominating Commission. Dana is a past member of the Board of Governors of the Washburn University School of Law and currently serves on the Washburn Law School Foundation Board of Directors.

**ROTARY INTERNATIONAL
DISTRICT 5670
BY-LAWS**

ARTICLE I MEMBERSHIP AND PURPOSE

Section 1. Membership. The membership consists of Rotary Clubs assigned by Rotary International to District 5670.

Section 2. Purpose. The purpose of the District is for the administration of Rotary International policies. District committees and programs shall exist solely to help individual clubs advance the object of Rotary.

Section 3. Extent of Authority. None of these By-Laws can alter in any way the By-Laws of Rotary International.

ARTICLE II CONDUCT OF DISTRICT AFFAIRS

Section 1. Term of Service. Normally, no Rotarian shall hold the same elective or appointive District position for more than three consecutive years.

Section 2. Voting. It is in the best interest of the District and Rotary International for committee members and representatives of District clubs to participate and to vote in District matters according to their best judgment based upon debate and discussion. Except where specifically required or permitted by Rotary International, proxy voting shall not be permitted in the conduct of District affairs, including District committee deliberations, the District Assembly, and the District Conference.

Section 3. Rules of Order. The rules of order contained in the current edition of Roberts Rules of Order (newly revised) shall govern unless and to the extent that such rules are inconsistent with the current Rotary International Manual of Procedure, these By-Laws, or any special rules of order that the District may adopt.

ARTICLE III DISTRICT OFFICERS

Section 1. District Governor. The District Governor is an officer of Rotary International, functioning under the supervision of the R.I. Board of Directors. He/She is responsible for direct supervision of the clubs in the District. He/She shall:

- a) Plan, develop, and preside at the District Conference;
- b) Serve as a member of the Heartland PETS Council and appoint members to serve on the four (4) HPETS committees;
- c) Transfer continuing District files to his/her successor; and
- d) Perform all other duties as inherent to his/her responsibilities as the office of Rotary International in the District.

Section 2. District Treasurer. The District Treasurer shall be appointed by the District Governor and will serve a term of one year but may be reappointed for an additional two years at the discretion of subsequent District Governors.

The District Treasurer shall:

- a) Collect all District funds and shall pay all District obligations under the direction of the District Governor;
- b) Send \$11 per each District Rotarian to the Secretary-Treasurer of the District Scholarship Program; and
- c) Shall maintain all District Financial reports.

Section 3. District Secretary. The District Secretary shall be appointed by the District Governor and shall serve a term of one year. The District Secretary shall:

- a) Assist the District Governor in making arrangements for District meetings and compile proper Minutes of such meetings;
- b) Maintain complete files and records of District business; and
- c) Deliver all continuing files and records to the incoming District Governor on July 1.

Section 4. District Historian. The District Historian shall be appointed by the District Governor to serve for one year. However, because of the long-term implications of this office, the District Historian may continue to serve as long as there is mutual agreement with subsequent District Governors. The District Historian shall maintain a continuing record of events in the District, and shall archive documents pertinent to the history of the District.

Section 5. District Trainer. The District Trainer shall be appointed by the District Governor to serve for one year, but may be appointed by the District Governor for an additional two terms at the discretion of subsequent District Governors. The District Trainer shall:

- a) Be a standing member of the HPETS Program Committee and perform duties as delegated by the HPETS Program Committee Chair; and
- b) Shall conduct training sessions for Assistant Governors and/or Club Presidents as requested by the District Governor.

Section 6. Assistant Governor. The District Governor may appoint up to eight (8) Assistant Governors to support and assist the District Governor with the administration of designated clubs. Matters related to the criteria selection, term of office, duties, and responsibilities are found in the District 5670 Leadership Plan. The District budget will include stipends to help defray the expenses of the Assistant Governors.

Section 7. Representatives to Council on Legislation. The representative and an alternate shall be elected at the District Conference in the preceding Rotary year in which the Council on Legislation is to meet. The election shall be held in accordance with the By-Laws of Rotary International (R.I.). The representative and alternate shall be, as required by R.I., a present or past officer of R.I. or the incoming District Governor.

ARTICLE IV DISTRICT COMMITTEES

District Committees are charged with carrying out the goals of the District as formulated by the District Governor with the advice of the Assistant Governors. All committee terms are for one year beginning July 1 except where otherwise noted. A list of all appointments shall be included in the District Directory, a copy of which is provided to each club in the District. Committees shall be appointed to address ongoing administrative functions, as follows:

Section 1. Resolution Committee. Each year the District Governor shall appoint a Resolution Committee of three (3) members. At least one member shall be a past District Governor. The Committee shall prepare appropriate resolutions for action at the District Conference.

Section 2. Graduate Student Scholarship Committee. The Committee shall consist of six (6) immediate past District Governors of District 5670. The Committee is charged with:

- a) The disbursement of all student scholarship funds. Each club in the District shall pay an annual contribution of \$11 per member based on membership as of March 31 each year. The annual contribution and grant per student each year shall not exceed the maximum provided through prior District action;
- b) Selection of students to receive monetary awards;
- c) Formulation of rules, recommendations, and regulations of the program;
- d) Provide an annual accounting summary to the immediate past District Governor by August 1.

Section 3. Nominating Committee. The Nominating Committee shall be composed of five (5) well informed Rotarians who have been active on the District level. They shall be selected by the District Governor to serve for a period of one year. Their activities will be governed by the following rules of procedure.

- a) The District Governor shall issue an announcement no later than the October issue of the District Newsletter inviting any club which desires to do so to submit its suggestion for nomination for District Governor for consideration by the Nominating Committee. The announcement by the District Governor shall state when such suggestions must be received by the Nominating Committee. The announcement by the District Governor shall include the address to which suggestions shall be sent. A suggestion shall be submitted in the form of a resolution adopted at a regular meeting of the club and certified by the Club Secretary. 1)
- b) The Nominating Committee shall not be limited in its selection to those names submitted by the clubs of the District.
- c) If the Nominating Committee cannot agree upon a candidate, the District Governor nominee shall be elected in a ballot-by-mail, each club shall have one vote for each 25 club members or major fraction thereof.
- d) Notwithstanding any nomination made by the Nominating Committee, any club may propose a candidate whose name had previously been duly suggested to the Nominating Committee by filing with the District Governor, a resolution of the club naming such candidate. The District Governor shall specify the deadline for the filing of any resolution when announcing the recommendation of the Nominating Committee's recommendation.
- e) If the date so fixed by the District Governor any such nomination has been received, the District Governor shall notify all clubs in the District of the names and qualifications of each candidate. All candidates will be voted upon by a ballot-by-mail as specified in item c) above. If no resolutions are

received by the deadline date, the District Governor shall declare the candidate of the Nominating Committee to be the District Governor Nominee and within fifteen (15) days thereafter shall so notify all clubs in the District.

- f) The District Governor shall certify the name of the District Governor Nominee to the General Secretary of Rotary International within ten (10) days after he/she has been declared to be the Nominee.
- g) A District Governor Nominee Designate may also be selected by the following steps (a-f) above.

Section 4. Finance Committee. The Finance Committee shall consist of the three (3) most recent Past District Governors. The most senior Past District Governor shall serve as the Committee Chair. The primary responsibilities are:

- a) To review the annual financial statement of District 5670 from the prior year;
- b) To consult with the District Governor on the current financial condition of District 5670.
- c) To work with the District Governor Elect in the preparation of the District budget for the coming year; and
- d) To present the proposed budget at the District Assembly on behalf of the District Governor Elect.

Section 5. Youth Exchange Committee. This Committee supervises and organizes in-bound and out-bound school year exchanges for high school age students in cooperation with districts in other countries. District 5670 shall be a member of the South Central Rotary Youth Exchange, Inc.

Section 6. RYLA Committee. This Committee develops, organizes, promotes, and implements an annual leadership training and development program in a camp format on a District-wide basis, in conjunction with Barton County Community College.

Section 7. Membership Committee. This Committee is responsible for District membership growth and works with the District Governor and Club presidents to enhance future membership retention and growth.

Section 8. Extension Committee. This Committee is responsible for finding opportunities within the District for extending Rotary and to work with the District Governor in coordinating the establishment of new clubs.

Section 9. District Governor Elect Advisory Committee.

- a) A Committee shall be created to advise the District Governor Elect regarding the District organization, programming, and appointments.
- b) The Advisory Committee shall be composed of the three most recent District Governors, the District Governor Nominee, and one other Rotarian named by the District Governor Elect.
- c) The Advisory Committee shall meet at the discretion of the District Governor Elect.

Section 10. Public Relations Committee. Develops and implements plans to providing the public with information about Rotary and assist clubs in promoting their projects and activities.

Section 11. Training Committee. Supports the District by training District and Club leaders.

Section 12. Rotary Foundation Committee. This Committee serves as the liaison between the Rotary Foundation and Club Rotarians. The District Governor is an ex officio member of the Committee. The Committee consists of a District Rotary Foundation Chair and three subcommittees as follows:

- a) Grants Subcommittee
- b) Fundraising
- c) Polio Plus

Additional subcommittees can be appointed by the District Governor as required.

Section 13. Ad Hoc Committees. The District Governor shall create other committees at the direction of Rotary International or as it would be considered in the best interests toward fulfilling the mission and programs of Rotary International and District 5670.

ARTICLE V. DISTRICT MEETINGS

Section 1. District Conference. The District Conference shall be held at such time and place and shall be selected by the District Governor Elect and approved by the majority of the Presidents Elect at the District Assembly provided that such dates are not the same as those for the International Assembly and the International Convention. The District Governor Elect shall announce the site and dates of his/her District Conference at the immediately preceding District

Conference. Clubs shall prepay the full District Conference registration fee for each elector as defined in ARTICLE VII, Section 2. Payments will be prescribed in ARTICLE VI, Section 2.

Section 2. District Assembly. Each District Club President Elect shall be expected to attend the District Assembly unless excused by the District Governor Elect. If so excused, he/she shall send a designated representative from the Club who shall act in his/her place. The District Assembly shall be held preceding the District Conference in order that actions at the District Assembly may be reported to the attendees of the District Conference by the District Governor Elect. Each President Elect shall have one vote and the presence of a majority of District Club President Elect or their designated representatives shall constitute a quorum for the transaction of business. The affirmative vote of a majority of votes cast shall be required for approval of any matter considered with the exception of the Finance Committee's recommended budget which shall be approved by three-fourths of the Presidents Elect present in person or by proxy voted by the designated representative of a President Elect excused from attendance by the District Governor Elect. If no District Assembly is held or if a quorum is not obtained at the District Assembly, any matter that otherwise could have been determined at such District Assembly including the Finance Committee's recommended budget may be determined in a ballot by mail in accordance with the current Rotary International Manual of Procedure.

Section 3. Presidents Elect Training (PETS) Seminar/Secretaries Elect Training (SETS) Seminar. Each District Club President Elect shall attend the Presidents Elect Training Seminar unless excused by the District designated representative from the Club whose duty it will be to report back to him/her. Clubs shall prepay the full registration fee for the President Elect or the designated representative as prescribed in ARTICLE VI, Section 4. Clubs are strongly urged to send their Secretaries Elect to the SETS program and to pay their registration fees as well.

Section 4. District Rotary Foundation Seminar. The District Rotary Foundation Seminar shall be held at a time and place as determined by the District Governor in collaboration with the District Foundation Coordinator. The date shall have been announced at the preceding District Assembly and District Conference. All Rotarians are encouraged to attend, but each Club is requested to appoint a Club Foundation Coordinator who shall attend the Seminar.

ARTICLE VI FINANCES

Section 1. Annual Dues. The annual dues for each member of District 5670 shall be \$20.00 per year subject to change by action at the District Assembly.

Section 2. District Conference Registration. Each Club of the District shall prepay to the District Conference a full registration fee for each elector as defined in ARTICLE VII, Section 2. Fee costs shall be included in the District invoice to each Club, and shall be based on the registration fee of the preceding District Conference. Clubs may choose to pay additional expenses of Conference attendees.

Section 3. PETS Registration. Each Club of the District shall prepay to District 5670 a full registration fee for the President Elect. The fee cost shall be included in the District invoice to each Club, and shall be based on the registration fee of the preceding PETS. Clubs are strongly encouraged to prepay for the Secretary Elect to attend SETS. Clubs may choose to pay in part or in total the transportation and lodging cost of the President Elect and Secretary Elect.

Section 4. District Governor Elect Expenses. The District shall provide at least \$2,300.00 for the District Governor Elect to attend the Zone Institute.

Section 5. District Governor Expenses. The District shall provide at least \$1,500.00 for the District Governor to attend the Zone Institute.

Section 6. District Governor Nominee Expenses. The District shall provide at least \$1,800.00 for the District Governor Nominee to attend the Zone Institute.

Section 7. District Resource Leader (DRL) Expenses. The District shall provide at least \$1,200.00 for the DRL to attend the Zone Institute.

Section 8. Assistant Governor Expenses. District Assistant Governors will be provided an honorarium of at least \$300.00 to help defray their costs in fulfilling their responsibilities. In addition, whenever possible, their registration fees will be paid or waived at District meetings, especially those circumstances where they are assigned duties and responsibilities.

Section 9. Representative to Council on Legislation Expenses. The District shall pay \$500.00 to help defray the expenses of the District representative to the Council on Legislation since said representative serves on behalf of the District. These funds will be paid unless all necessary expenses are paid by Rotary International.

Section 10. District Scholarship Program. The annual per capita assessment shall be \$11.00 for each Rotarian in the District.

Section 11. District Governor Honorarium. The District Governor shall receive the sum of \$2,000.00 from the District as an honorarium in recognition of his/her service to the Rotarians of District 5670. The District Governor is encouraged to attend the Rotary International Convention.

ARTICLE VII. AMENDMENTS

Section 1. Changes. The By-Laws may be amended or altered by a majority vote of the certified electors at the District Conference.

Section 2. Electors. Each Club shall select, certify, and send to the District Conference one (1) elector for every twenty-five (25), or major fraction thereof, of its members, based on the membership as of the last day of the month preceding the District Conference in accordance with the By-Laws of Rotary International.

Section 3. Notice. Proposed amendments shall be given in writing to the Presidents of each Rotary Club assigned to District 5670 at least twenty-one (21) days prior to the date that the proposed amendments will be voted upon.

Section 4. By-Law Committee. After any assembly, the by-laws may be amended by 2/3's consent of the By-Law Committee. The By-Law Committee shall consist of the four of the most recent past District Governors who are ready, willing and able to serve, the District Governor, the District Governor Elect, the District Governor Nominee, and the District Governor Nominee Designate. The District Governor may appoint one or more Assistant Governors and one or more Past District Governors who agree to serve on the By-Law Committee. Any By-Law Amendments adopted under this section shall be sent to the presidents and secretaries of each Rotary Club, and presented for ratification, amendment or rejection at the next District Assembly.
